## **GST UPDATES**



GST Rate revisions
 GST Updates (Effective October 10, 2024)

GST Rate	Changes/Items Added			
2.5%	Applied to specific pharmaceuticals including Trastuzumab Deruxtecan, Osimertinib, and Durvalumab			
6%	Included extruded or expanded savory/salted products, excluding unfried/uncooked snack pellets.			
9%	- Expanded to include extruded/expanded savory products.			
	- Updated tax on <b>seats</b> (excludes aircraft and motor vehicle seats).			
14%	Added motor vehicle seats.			

- For metal scrap transactions and renting of nonresidential property involving an unregistered supplier, the GST liability will now rest with the registered recipient under the reverse charge mechanism (RCM). The recipient is responsible for directly remitting the GST to the government.
- E-Way Bill generation will be restricted to documents dated within 180 days, and extensions will be limited to 360 days from the original date of generation. Taxpayers are advised to activate MFA promptly and ensure registered mobile numbers are updated.
- The Central Government has waived the late fee for GSTR-7 returns (from June 2021 onwards) beyond ₹25 per day, up to a maximum of ₹1,000. Additionally, no late fee will be levied for months where nil TDS was

- deducted. This supersedes Notification No. 22/2021-Central Tax and comes into effect from November 1, 2024.
- Notification No. 25/2024-Central Tax (Effective October 10, 2024) requires registered persons to deduct TDS on metal scrap (Chapters 72–81 of the Customs Tariff Act, 1975) under Section 51 of the CGST Act, 2017.
- The GST Council, in the 55th GST Council Meeting, has recommended-
  - To reduce the GST rate on Fortified Rice Kernels, classifiable under 1904, to 5% irrespective of end use.
  - To fully exempt Gene Therapy from GST.
  - To extend IGST exemption to systems, sub-systems, equipment, parts, sub-parts, tools, test equipment, software meant assembly/manufacture of LRSAM system under Notification 19/2019-Customs.
  - To reduce the rate of Compensation Cess to 0.1% on supplies to merchant exporters at par with GST rate on such supplies.
  - To exempt from IGST imports of all equipment and consumable samples by Inspection Team of the International Atomic Energy Agency (IAEA) subject to specified conditions.
  - To extend the concessional 5% GST rate on food inputs of food preparations under HSN 19 or 21 that are supplied for food preparations intended for free distribution to economically weaker sections under a government program subject to the existing conditions.

## **INCOME TAX UPDATES**

- CBDT extends due date for determining amount payable as per column (3) of Table specified in section 90 of Direct Tax Vivad Se Viswas Se Scheme, 2024 from 31st December, 2024 to 31st January, 2025.
- CBDT extends the last date for furnishing Belated / Revised return of income for AY 2024-25 in the case of Resident Individuals from 31st December, 2024 to 15th January, 2025.

## **MCA UPDATES**

- Ministry of Corporate Affairs, via Notification No.G.S.R.630 (E) dated 9th October 2024: The Central Government has notified the Companies (Adjudication of Penalties) Second Amendment Rules, 2024, clarifying the proceedings pending before the Adjudicating Officer or Regional Director.
- Ministry of Corporate Affairs, via Notification No. G.S.R 794 (E) dated 31st December, 2024: The date for filing Form CSR-2 for the financial year 2023-24 has been extended to 31st March 2025.
