## **GST UPDATES**

- Two new tables, 14A and 15A have been introduced in GSTR-1 to capture the amendment details of the supplies made through e-commerce operators (ECO) on which e-commerce operators are liable to collect tax under section 52 or liable to pay tax u/s 9(5) of the CGST Act, 2017.
- Amendment in the Manner of distribution of ITC by the ISD (Section 20 of the CGST Act), inclusion of Reverse Charge Mechanism (RCM) invoices in clause (61) of Section 2. This change mandates the inclusion of RCM invoices within the ISD mechanism for the distribution of ITC from the Head Office to branches exclusively,
- following this amendment, any tax paid by an ISD under RCM can only be distributed to branches under ISD rules, with no other methods like cross charges being allowed. This regulatory update is intended to establish consistency in ISD-related compliance across all taxpayers.
- The Finance Act 2024 has also introduced a new section, 122A, that imposes penalties for the failure to register certain machines used in the manufacture of goods. This special procedure, notified under Section 148 of the CGST Act, 2017 specifically applies to goods like tobacco, pan-masala, and similar items.

### **INCOME TAX UPDATES**

- No changes were made to direct and indirect tax rates.
   The existing tax rates remain in place.
- The government focused on improving taxpayer services and withdrew old disputed direct tax demands up to Rs 25,000 till FY 2009 and Rs 10,000 for 2010-11 to 2014-15, benefiting around 1 crore taxpayers.

### **MCA UPDATES**

New rule was implemented by MCA called Companies (Listing of equity shares in permissible jurisdictions) 2024. It establishes guidelines for the Indian companies to list their shares internationally.

- Application The provisions of these rules shall apply to;
   (a) unlisted public companies;
  - (b) listed public companies, so far as they are in accordance with regulations framed or directions issued in this regard by the Securities and Exchange Board or the Authority, which issue their securities for the purposes of listing on permitted stock exchanges in permissible jurisdictions.
- The unlisted public company shall file the prospectus in e-Form LEAP-1 specified in the Second Schedule along with the fees within a period of seven days after the same has been finalised and filed in the permitted exchange.

Extension of last date of filling of Form No. LLP BEN-2 and LLP Form No.4D, without payment of additional fees, up to 15th May 2024.
